Dates of Interest

- 1944 Florence Li Tim Oi, is ordained in Hong Kong, the first woman priest in the Anglican Communion
- 1946 Women sent a message to the General Convention requesting that the term "laymen" be interpreted as inclusive of women, in order that they might participate in the voting bodies of the church. This request as well as similar resolutions were defeated by the all-male General Convention year after year.
- 1964 The House of Deputies is reprimanded by the Presiding Bishop for yet again voting down the inclusion of women in its body.
- 1967 The constitutional amendment allowing women to participate as voting members of the house of deputies passes.
- 1969 women are allowed to be lectors and chalice bearers
- 1970 women deputies attend convention, marking the first time women are allowed to vote in this legislative body of the Episcopal church
- 1974 Two retired and one resigned bishop "irregularly" ordain 11 women in Philadelphia.
- 1974 IntegrityUSA, is founded, an organization with full LGBT+ inclusion in the Episcopal Church as it's goal
- 1976 Convention narrowly approves changes allowing for women's ordination.
- 1976 Convention affirms "homosexual persons are children of God who have a full and equal claim with all other persons upon the love, acceptance, and pastoral concern and care of the church."
- 1988 Barbara Harris is elected the first woman bishop in the Anglican Communion.
- 1988 The national Episcopal AIDS foundation created for education and support of ministries through the church
- 1994 Convention changes the canons to prevent discrimination based on sexuality in the church including membership and ordination.

- 2003 The diocese of New Hampshire elects the first openly gay bishop, Gene Robinson, whose election is affirmed by vote at the General Convention
- 2006 Katharine Jefferts Schori becomes the first female Presiding Bishop
- 2009 Convention affirms the place of same-sex couples in the church, and expresses support for national laws that prevent discrimination.
- 2012 Convention changes the canons to prevent discrimination for ordination based on gender identity or expression
- 2015 Convention approves rites for same-sex marriage services
- 2018 Episcopal churches whose clergy do not want to perform same-sex marriages, must now make provision for another clergy person to perform the service, in the couple's home parish.
